1. Departmental Training Programme for Junior Scale Officers of Goa Civil Services: The Departmental Training Programme for the Junior Scale Officers of Goa Civil Service (Promotees) has commenced from 27th June, 2022 and is presently being conducted for a period of 45 days. There are 15 Officers of the Goa

Civil Service attending this programme. Till 30th July, they have completed 30 days of training. The sessions for the said programme are being conducted by resource persons who belong to the State administration, Human Resource Trainers, Retired officers from the State administration. Officers from Government of India, are also invited as resource persons.

2. In-service Training Programme for Co-operation Department: The valedictory function for the 90 days In-service Training Programme for Co-operation Department was concluded on 25th July, 2022. Sh. Subhash Shirodkar, Hon'ble Minister Co-operation, delivered the key note address and distributed certificates to the 41 trainees. Sh. M.R.M. Rao, IAS, Secretary Co-operation, Sh. Michael M. D'Souza, IAS, Director Training GIPARD and Sh. Vishant Gaunekar, Registrar of Co-operation were also present during the occasion. The programme was conducted since 24th

March 2022. The training included sessions on the Goa Co operative Society's Act and Rules, Audit Procedures, functioning of Co operative Societies in Goa, Financial matters and general Administration. The trainees were also required to prepare a project on co operative societies in Goa. An exposure visit to Goa Institute of Management and Vaikunth Mehta National Institute of Cooperative Management were undertaken during the programme. Sh. Subhash Shirodkar, Hon'ble Minister Co-operation said that Sahakar (Co-operation) is the culture of living and has great significance in upbringing of individual. The Co-operation Department requires vibrant change in its functioning as far as the audit sector is concerned and informed that the Department will work on executing effective methods in delivering its service to the public. The Minister appealed to all the Officers, who attended the training session to work hard as they share huge responsibilities in extending excellent service to the public at large. Sh. M.R.M. Rao, IAS, Secretary Co-operation, lauded the efforts of the GIPARD for conducting comprehensive training courses and appealed to all the Officers in the Department to work for the betterment of the State.



3. Programme on Right to Information Act: was held on 25th July 2022 for the PIOs of Government Department. The officers were from different departments and Junior Scale Officers of Goa Civil Service (Promotees). 25 participants attended the programme. Sh. Pralhad Kachare, Master Trainer in RTI former Registrar, YASHADA delivered the sessions.

Decentralized Planning,
Monitoring & Evaluation Sector:**

1. Three days Training Programme on PRI-SHG Convergence for SHG Members was organized in 08 batches from 4th to 30th July, 2022 at Village Panchayat Hall of Salcete, Sattari, Bardez, Ponda, Mormugao and Tiswadi Goa and at Collectorate hall of Dharbandora - Goa. The training sessions were attended by 347



participants. The aim of the training programme was to sensitize the SHGs on Conceptual inputs on Panchayati Raj Institutions, importance of involving SHGs and their Federation in GDPD process at village level, imparting information on Gram Sabha, Swachh Bharat Mission, Sustainable Development Goals, etc. The sessions during the training programme was delivered by State Resource Persons and Faculty Member of GIPARD.



2. Workshop - cum - Refresher Training Programme was organized for Zilla Panchayat Members of North Goa & South Goa Districts on 19th July, 2022 at GIPARD, Ella Farm, Old Goa, Goa. Total 35 participants attended the above cited training programme. The aim of the training sessions was to enable participants to state the role of District Planning Committees in Rural Development, functioning of Zilla Panchayat and the overall socio-economic development of the state, sensitize on functioning of eGram Swaraj Portal for effective utilization of 15th Finance Commission Funds through implementation of Zilla Panchayat Development Plan (ZPDP) works / projects at District level and explain operational guidelines of Swachh Bharat Mission -Grameen Phase II. The sessions during the training programme was delivered by Resource Person Dr. Jiju P Alex, Member of Kerala State Planning Board, Kerala, State Resource Person of GIPARD and Master Trainers of eGram Swaraj Application.



3. **Refresher Training for Councillors of various Municipal Councils and Corporation of the City of Panaji (CCP)** was organized in 02 batches on **22nd July 2022 and 26th July, 2022 at GIPARD, Ella Farm, Old Goa, Goa.** Total **36 participants** attended the above cited training programme. The aim of the training sessions was to enable participants to

state the Constitutional framework and provisions of the Municipal Solid Waste Management Rules, 2016, Swachh Bharat Campaign and ODF in ULBs, also to state the role of District Planning Committees (DPCs) in Urban Development, Devolution of Funds and Revenue Generation by ULBs and Status of implementation of the different Centrally / State Sponsored Schemes. The sessions during the training programme was delivered by Officials of Goa State Urban Development Agency (GSUDA), Goa State Pollution Control Board and Director (Training), GIPARD.

1. **2 Batches of Orientation of V.O. and SHG under NRLM** were held for SHG and VO members of Querim V.P. on **7th July, 2022** and Volvoi V.P. on **26th July, 2022** in Ponda Block. The aim of the programme was to enable participants to function their VOs as per the guidelines of GSRLM and function their SHGs as per the NRLM compliance. Total **164 participants**

attended the training programme. Around 38 SHG's took part in the trainings.

Mulgao V.P., Bicholim Block and **29th to 30th July, 2022** at Mayem V.P., Bicholim Block. The aim of the programme was to enable participants to explain the role Sub Committees of Village Organizations under NRLM. **Total 372 participants** attended the training programme. Around 53 V.O.s took part in the trainings.

1. A five days MoRD, sponsored Training Programme on **Impact of Climate Change on Natural Resources** was held from **18th to 22nd July, 2022** at GIPARD, Ella Farm, Old Goa. The aim of the programme was to enhance their knowledge on **SDG Goal Number 13 viz Action to Combat Climate Change** and discuss various ways on

handling Environmental issues.
